

4. Representations and Warranties. Assignors have full right, title and interest in and to the Marks.

5. Governing Law. Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment shall be governed by and construed in accordance with Colorado law.

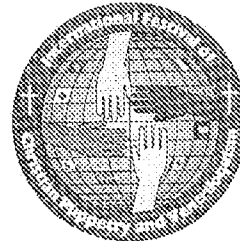
