Release of Lien on Trademarks

THIS RELEASE OF LIEN ON TRADEMARKS is entered into as of September 26, 2011 by and between LPS IP HOLDING COMPANY, LLC, a Delaware limited liability company (the “**Assignor**”) and JPMORGAN CHASE BANK, N.A., as collateral agent (the “**Assignee**”) for the lenders party to the Credit Agreement.

WHEREAS, pursuant to the terms and conditions of that certain Security Agreement dated as of July 8, 2008, as amended and restated by that certain Amended and Restated Security Agreement dated as of August 18, 2011 (the “**Security Agreement**”; all capitalized terms used but not defined herein shall have the respective meanings ascribed thereto in the Security Agreement), the Assignor granted to the Assignee a continuing security interest in and lien on all of their right, title and interest in and to the trademarks and trademark applications set forth on Schedule A hereto;

WHEREAS, the Assignor entered into those certain Trademark Security Agreements dated as of July 2, 2008, March 26, 2009, July 28, 2010, November 26, 2010, March 31, 2011 and August 18, 2011 (the “**Agreements**”) with the Assignee to evidence its grant of a security interest in the trademarks and trademark applications set forth on Schedule A hereto;


WHEREAS, the Agreements relating to the trademarks and trademark applications were recorded with the United States Patent and Trademark Office on August 20, 2008 on reel 3838 frame 0348, April 10, 2009 on reel 3968 frame 0844, August 11, 2010 on reel 4258 frame 0827, December 9, 2010 on reel 4429 frame 0099, May 19, 2011 on reel 4544 frame 0510 and August 18, 2011 on reel 4607 frame 0161;

WHEREAS, the Assignee desires to release its security interest in and lien on the trademarks and trademark applications set forth on Schedule A hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignee does hereby release its security interest in and lien on the trademarks and trademark applications set forth on Schedule A hereto and reassigns to the Assignors all right, title and interest of the Assignee in and to such trademarks and trademark applications.


