TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement is effective as of September 26, 2011 ("Effective Date") by and between Minnesota Public Radio, a Minnesota non-profit corporation ("Assignor"), having a mailing address of 480 Cedar Street, St. Paul, Minnesota 55101, to Public Broadcasting of Colorado, Incorporated, a Colorado nonprofit corporation ("Assignee"), having a mailing address of 7409 S. Alton Court, Centennial, CO 80112.

WHEREAS, Assignor is the owner of the "Open Air" service mark, and the associated federal registration in the United States (Registration No. 3001604), for use in connection with "radio programming; distribution of radio programs for others; entertainment in the nature of on-going radio programs in the field of music, commentary and interviews; and entertainment services, namely, providing radio programming and information in the field of music, commentary and interviews via a global computer network" in International Class 41 (the "Mark").

WHEREAS, Assignee desires to acquire all right, title and interest in and to the Mark.

NOW, THEREFORE, for \$10 and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign and transfer to Assignee all right, title and interest in and to the Mark, together with the goodwill symbolized by said Mark, and Assignor hereby agrees to take such other actions as are reasonably necessary to transfer and assign the Mark to Assignee.
