Release of First Lien Trademark Security Agreement

This Release of First Lien Trademark Security Agreement (the "Release"), dated as of September 27, 2011 is made by UBS AG, STAMFORD BRANCH, in its capacity as collateral agent pursuant to the First Lien Credit Agreement, dated as of November 10, 2005 (in such capacity, the "Collateral Agent") in favor of QTC MANAGEMENT, INC. (the "Pledgor").

WHEREAS, in connection with the First Lien Credit Agreement and a First Lien Security Agreement, each dated as of November 10, 2005, Pledgor entered into a First Lien Trademark Security Agreement dated as of November 10, 2005 and recorded in the United States Patent and Trademark Office as of December 6, 2005 at Reel 003205, Frame 0020 pursuant to which Pledgor granted to the Collateral Agent a security interest in and lien on all right, title and interest of Pledgor in certain trademarks, including the trademarks and trademark applications set forth on Schedule I attached hereto (the "Released Trademarks") to secure the performance of certain obligations (the "Obligations");

WHEREAS, the Obligations have now been satisfied, Pledgor has requested that the Collateral Agent release any and all interest it may have in the Released Trademarks pursuant to the First Lien Security Agreement and First Lien Trademark Security Agreement, and the Collateral Agent has agreed to do so.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent does hereby release, relinquish and discharge its security interest in, to and under the Released Trademarks.
