## TRADEMARK ASSIGNMENT – NUNC PRO TUNC

**WHEREAS**, ASSIGNEE is desirous of acquiring the Mark and the goodwill of the business associated therewith, as well as the registration therefor.

**NOW THEREFORE**, ASSIGNOR hereby conveys, transfers, and assigns to ASSIGNEE *nunc pro tunc* September 15, 2009 all its rights, title, and interest in and to the Mark, as well as the registration therefor, together with the goodwill of the business symbolized thereby.


ASSIGNOR further assigns to ASSIGNEE all rights to sue for and receive all damages occurring from any past infringing uses of the Mark.
