## **RELEASE OF TRADEMARKS**

This RELEASE OF TRADEMARKS AGREEMENT (the "Release Agreement"), dated as of September 27, 2011, made by JPMORGAN CHASE BANK, N.A., the successor in interest to BANC ONE CAPITAL PARTNERS II, LLC, BANK ONE, NA and BANK ONE, TEXAS, N.A. ("Lender"), in favor of MEDIA RECOVERY, INC., DATASPAN, INC., SHOCKWATCH, INC., and MRI DPC, INC. (Collectively referred to as "Borrowers").

## **RECITALS**

**WHEREAS**, Borrowers and Lender entered into a certain Security Agreement, first dated as of November 6, 1997 and amended through October 1, 2008 (the "Security Agreement"), pursuant to which Borrowers granted to Lender a lien on and security interest in certain trademarks owned by Borrowers, including, without limitation, the trademarks identified on Schedule A attached hereto (the "Trademarks"), said lien recorded in the United States Patent and Trademark Office on the dates and at the Reel and Frame indicated on Schedule A.


**WHEREAS**, in accordance with the terms of the Security Agreement, Borrowers have satisfied all of their outstanding obligations under the Security Agreement, and in connection therewith, Borrowers have requested and Lender has agreed to release its lien on all Trademarks pledged pursuant to the Security Agreement.

## **AGREEMENT**

Lender hereby releases and terminates all right, title and interest pledged, hypothecated, assigned, transferred, deposited and granted to it by Borrowers pursuant to the Security Agreement in the Trademarks pledged pursuant to the Security Agreement (the "Released Collateral"), and all liens, security interests, charges or other encumbrances in favor of Lender in the Released Collateral shall hereby terminate and revert to Borrowers and all right, title and interest of Lender in the Released Collateral will hereby cease, terminate and become void.
