ARTICLES OF CONVERSION

Pursuant to the Section 490A.304 of the Iowa Limited Liability Company Act (the "LLCA"), Bandag, Incorporated, an Iowa corporation (the "Corporation"), hereby adopts the following Articles of Conversion for the purpose of converting the Corporation into an Iowa limited liability company upon the effective date set forth below:

- FIRST: The Corporation was first formed on December 20, 1957 in the State of Iowa.
- SECOND: The name of the Corporation immediately prior to the filing of these Articles of Conversion was Bandag, Incorporated.
- THIRD: The name of the limited liability company shall be:

- FOURTH: In accordance with Section 490A.304(8) of the LLCA, the Corporation properly approved the operating agreement of Bridgestone Bandag, LLC on June 1, 2007.
- FIFTH: The effective date of the conversion of Bandag, Incorporated to Bridgestone Bandag, LLC shall be June 1, 2007.
