TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this "Agreement") is entered into effective as of the 28th day of January 2011 (the "Effective Date"), by and between BIONOVA PRODUCE, INC., an Arizona corporation (the "Assignor") and MASTERSTOUCH BRAND L.L.C., an Arizona limited liability company (the "Assignee").

WITNESSETH:

WHEREAS, Assignor and Assignee have entered into a certain Asset Purchase Agreement dated the 28th day of January 2011 by and between Assignor and Assignee, as amended by the First Amendment to Asset Purchase Agreement dated effective as of the 28th day of January 2011 (the "Asset Purchase Agreement"), pursuant to which Assignor has agreed to sell, assign and transfer to Assignee, and Assignee has agreed to purchase from Assignor, among other assets, the Intellectual Property, as defined below;

WHEREAS, Assignor is the owner of all right, title, and interest in and to those certain trademarks and registrations set forth on Attachment 1, hereto (the "Intellectual Property"); and

WHEREAS, for good and valuable consideration and upon the terms and conditions set forth below, Assignor desires to assign all of its rights and interests with respect to the Intellectual Property to Assignee and Assignee desires to accept such assignment and assume all rights and obligations of Assignor associated with the Intellectual Property.

NOW, THEREFORE, in consideration of the transactions contemplated by this Agreement and the Asset Purchase Agreement and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree to the following:

1. **Defined Terms.** All capitalized words and terms used in this Agreement and not defined herein shall have the respective meanings ascribed to them in the Asset Purchase Agreement.
2. **Assignment.** Assignor hereby assigns and transfers unto Assignee, its successors, heirs, and subsequent assignees all right, title, and interest in and to the Intellectual Property, including, without limitation, the right to any applications, registrations, continuations, divisionals, reissues or reexaminations thereof, the right to prosecute any applications therefor, the right to have any applications, registrations, continuations, divisionals, reissues, or reexaminations issue in the name of the Assignee, the right to apply for and obtain any renewal of any registrations thereof, the right to sue for past and future infringement, and the right to the goodwill of the business symbolized thereby.
3. **Further Assurances.** Assignor will execute, at Assignee's expense, all such additional documents as may be reasonably necessary in the reasonable opinion of counsel for Assignee to perfect the assignment of rights set forth herein.

4. Estoppel License. To the extent the assignment under Section 1 fails or is judged ineffective for any reason, Assignor shall grant and hereby grants to Assignee a perpetual, irrevocable, fully paid-up, royalty free, exclusive (including as to Assignor) license to use, perform, display, reproduce, modify, enhance, create derivative works and improvements from, sublicense (through one or more tiers), distribute, transfer, reverse engineer, manufacture, make, have made, use, have used, import, have imported, sell, have sold or otherwise exploit in any lawful manner in any jurisdiction, under the Intellectual Property.

5. Binding Provisions. This Agreement is binding upon, and inures to the benefit of, the parties hereto and their respective administrators, personal and legal representatives, successors, and permitted assigns.




