**RELEASE OF INTELLECTUAL PROPERTY
(TRADEMARKS)**

Release of Intellectual Property (this "Release"), dated as of the 30th day of September, 2011, made by PNC Bank, National Association (the "Lender"), in favor of SiVance, LLC (the "Pledgor").

R E C I T A L S

A. The Pledgor and Lender entered into a certain Trademark Assignment of Security, dated as of February 17, 2011 (the "Agreement"), pursuant to which the Pledgor granted to the Lender a lien on and security interest in certain intellectual property collateral owned by the Pledgor; capitalized terms used herein and not defined shall have the meanings set forth in the Agreement. The Lender recorded an assignment document with respect to the Trademarks with the Assignments Division of the United States Patent & Trademark Office on February 22, 2011 at Reel 004483, Frame 0923.

B. In accordance with the terms of the Agreement, the Pledgor has satisfied all of its outstanding obligations under the Agreement and, in connection therewith, the Pledgor has requested Lender to release, and Lender has agreed to release, its lien on all Trademarks pledged pursuant to the Agreement.

A G R E E M E N T


