
**SUPPLEMENT TO

Grantors, as collateral security for the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Obligations hereby mortgage, pledge and hypothecate to Collateral Agent, for the benefit of Collateral Agent and Lenders, and grant to Collateral Agent, for the benefit of Collateral Agent and Lenders, a Lien on and security interest in, all of each Grantor's right, title and interest in, to and under the Trademark Collateral of such Grantor, including, without limitation, the trademarks listed on Schedule 1 of this Supplement to Amended and Restated Trademark Security Agreement. The undersigned Grantors further agree that this Supplement to Amended and Restated Trademark Security Agreement may be attached to that certain Amended and Restated Trademark Security Agreement, dated December 14, 2010, between the undersigned, as Grantors, and General Electric Capital Corporation, as Collateral Agent, (the "Amended and Restated Trademark Security Agreement") and that the trademarks listed on Schedule 1 of this Supplement to Amended and Restated Trademark Security Agreement shall be and become a part of the Trademark Collateral referred to in said Amended and Restated Trademark Security Agreement and shall secure all Obligations referred to in said Amended and Restated Trademark Security Agreement.

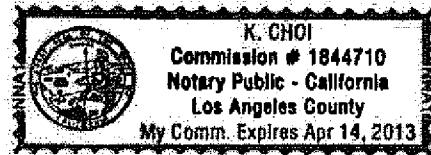
