4. Paragraph 8. of the Articles of Incorporation are amended to delete the word "none" and replace it with the following:

"1. The right to transfer shares in the capital stock of the Corporation is restricted and no shares of the Corporation shall be transferred without the consent of the Board of Directors evidenced by Resolution of the Board.

2. The number of shareholders of the Corporation, exclusive of persons who are in its employment and exclusive of persons who, having been formerly in the employment of the Corporation were, while in that employment, and have continued after termination of that employment to be, Shareholders of the Corporation, is limited to not more than fifty, two or more persons who are in the joint registered owners of one or more shares being counted as one Shareholder.

3. Any invitation to the public to subscribe for the securities of the Corporation is prohibited."
