SECURITY SUPPLEMENT


This SECURITY SUPPLEMENT, dated as of September 30, 2011, is delivered pursuant to the Pledge and Security Agreement, dated as of April 11, 2011 (as it may from time to time be amended, modified or supplemented in accordance with its terms, the "Pledge and Security Agreement"), among Grande Communications Networks LLC, a Delaware limited liability company, Grande Parent LLC, a Delaware limited liability company, Grande Communications Management Co., a Delaware corporation (each of the foregoing, a "Grantor", and collectively, the "Grantors"), and Société Générale, as Collateral Agent for the Secured Parties (as defined therein) (herein in such capacity, the "Collateral Agent"). Grande Communications Networks LLC (the "Undersigned Grantor") confirms, as set forth in the Pledge and Security Agreement, that it pledges, assigns, transfers and grants to the Collateral Agent, for its benefit and for the benefit of the Secured Parties, a continuing security interest in, and Lien on, all of its right, title and interest in, to and under the Collateral, in each case whether now owned or hereafter acquired or existing and wherever located, as security for the prompt and complete payment and performance in full when due (whether at stated maturity, by required prepayment, declaration, acceleration, demand or otherwise, including the payment of amounts that would become due but for the operation of the automatic stay under Section 362(a) of the Bankruptcy Code) of all Secured Obligations in accordance with the terms of the Pledge and Security Agreement.

The Undersigned Grantor represents and warrants that the attached supplements to Schedules accurately and completely set forth all information required pursuant to the Security Agreement and hereby agrees that such supplements to Schedules will constitute part of the Schedules to the Pledge and Security Agreement.
