

Pursuant to Section 18-209(c) of the Delaware Limited Liability Company Act (the "DLCA"), Triumph Aerostructures, LLC (the "Company"), a Delaware limited liability company and wholly-owned subsidiary of Triumph Group Inc., a Delaware corporation ("Triumph"), hereby certifies the following information relating to the merger of Vought Aircraft Industries, Inc. ("Vought"), a Delaware corporation and wholly-owned subsidiary of Triumph, with and into the Company (the "Merger"):

FIRST: The name and states of formation and incorporation of each of the constituent entities (the "Constituent Entities") are:

FIFTH: This Certificate of Merger shall become effective upon filing hereof with the Secretary of State of the State of Delaware.


