**ASSIGNMENT AND RELEASE OF
SECURITY INTEREST**

September 12 2011

This Assignment and Release of Security Interest (this "Release") is dated as of the date first set forth above. Reference is hereby made to: (i) that certain Grant of Trademark Security Interest (the "Original Trademark Security Agreement"), dated as of April 20, 2006, and (ii) that certain Amended and Restated Grant of Trademark Security Interest (the "A&R Trademark Security Agreement", and, collectively with the Original Trademark Security Agreement, the "Trademark Security Agreements"; capitalized terms used but not defined herein shall have the meanings given to them in the A&R Trademark Security Agreement), dated as of December 22, 2009, in each case, by Polar Corporation, a Minnesota corporation ("Assignor"), in favor of Wells Fargo Bank, National Association, a national banking association, in its capacity as administrative agent pursuant to the Credit Agreement (in such capacity, the "Administrative Agent"), recorded with the United States Patent and Trademark Office (the "USPTO") on the following dates in the following locations: (i) May 1, 2006, at Reel 3300, Frame 0138 (as corrected by the Corrective Assignment recorded August 30, 2011, at Reel 4613, Frame 0861), (ii) December 31, 2009, at Reel 4122, Frame 0986, and (iii) January 4, 2010, at Reel 4123, Frame 0645 (as corrected by the Corrective Assignment recorded August 25, 2011, at Reel 4611, Frame 0710).

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby notifies, acknowledges and agrees with Assignor that (i) the lien on and security interest in the Trademark Collateral pledged and granted by such Assignor to the Administrative Agent for the ratable benefit of the secured parties, including, without limitation, the lien on and security interest in the trademarks listed on the attached Schedule A and any after-acquired trademarks, is terminated, released and discharged fully, (ii) the Administrative Agent hereby releases and forever discharges fully all of its right, title and interest in, to and under, and of any kind or nature in the Trademark Collateral granted, assigned or conveyed pursuant to the Trademark Security Agreements, and (iii) any right, title or interest of the Administrative Agent in, to and under the Trademark Collateral shall hereby cease and become void. The Administrative Agent hereby retransfers and reassigns to Assignor, without representation or warranty, all of the Administrative Agent's right, title and interest in, to and under the Trademark Collateral.



The Administrative Agent agrees to timely execute and deliver such other documents, and take all actions, as may be reasonably requested by the Assignor, or its designee, to carry out and consummate this Release.

The Administrative Agent hereby authorizes and requests the Commissioner of Patents and Trademarks and any other applicable government officer to record this Release.
