## RELEASE OF SECURITY INTEREST IN TRADEMARKS

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made this 30th day of September, 2011, by BMO Harris Bank, N.A., (successor in interest by merger to M&I Marshall & Illsley Bank, as successor in interest by merger to First Indiana Bank) as agent for the Lenders (in such capacity "Agent").

**WHEREAS**, reference is made to that certain Assignment, Security Agreement and Mortgage dated as of August 1, 2000 by and between T2 Systems, Inc., an Indiana corporation ("Grantor") and Agent (as amended to date, the "Trademark Security Agreement").

**WHEREAS**, in connection with the Trademark Security Agreement, the Grantor granted Agent, for the benefit of the Lenders (as defined in the Trademark Security Agreement), a continuing security interest in all of the right, title and interest of Grantor in and to the trademark collateral identified therein (the "Trademark Collateral").

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on August 7, 2000, at Reel 2137 Frame 0484.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby irrevocably and forever releases, terminates, re-assigns and discharges any and all of its security interests in and to the Trademark Collateral including, without limitation, the Trademarks described in the schedules attached to the Trademark Security Agreement and attached as Schedule 1 hereto. Further, Agent understands and agrees that that this Release may be recorded by or for the Grantor with the United States Patent and Trademark Office and any other similar office or agency throughout the world. Agent also agrees, solely at the expense of the Grantors, to execute any other documents and take any

further action reasonably necessary in any state, country or jurisdiction that the Grantors may reasonably require to effect the intent and purpose of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of New York without regard to conflicts of law principles (other than Sections 5-1401 and 5-1402 of the New York General Obligations Law).

This Release may be executed by facsimile transmission or other electronic means, which signature shall be considered and original executed signature.
