**ARTICLES OF AMENDMENT OF THE ARTICLES OF INCORPORATION**  
**OF**  
**NATIONAL ASSOCIATION OF CERTIFIED VALUATION ANALYSTS, INC.**

Pursuant to Section 16-10a-1006 of the Utah Revised Business Corporation Act, the officer named below causes these Articles of Amendment of the Articles of Incorporation of National Association of Certified Valuation Analysts, Inc. to be delivered to the Utah Division of Corporations for filing and states as follows:


1. The name of the corporation is National Association of Certified Valuation Analysts, Inc. (the "Corporation").
2. Article I of the Corporation's Articles of Incorporation is hereby amended to read in its entirety as follows:

**"ARTICLE I--NAME"**

The name of the Corporation is National Association of Certified Valuers and Analysts, Inc."

3. The amendment was adopted by the unanimous approval of the directors and shareholders of the Corporation on the date hereof. The Corporation has 1,020 shares of common stock outstanding, all of which were entitled to vote on, and all of which were voted in favor of, the amendment.
