3. The foregoing amendment of Articles of Incorporation has been duly approved by the Board of Directors.

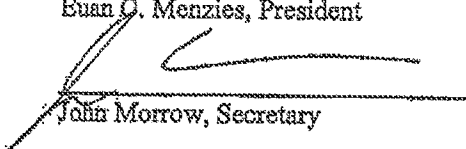
