**Under Section 805 of the Business Corporation Law**

It is hereby certified:

**FIRST:** The name of the corporation is Nycomed US Inc. (the "Corporation"). The name under which the corporation was formed is Pharma, Inc.

**SECOND:** The Certificate of Incorporation of the Corporation was filed by the Department of State on November 16, 1998.

**THIRD:** The amendment of the Certificate of Incorporation of the Corporation effected by this Certificate of Amendment is to change the name of the Corporation to Fougera Pharmaceuticals Inc.

**FOURTH:** To accomplish the foregoing amendment, Article FIRST of the Certificate of Incorporation of the Corporation, relating to the Corporation's name, is hereby amended to read as follows:


