## RELEASE OF TRADEMARK SECURITY INTEREST

TO HAVE AND TO HOLD the Trademarks free, clear and discharged from the encumbrance of the security interests granted by the Security Agreements.





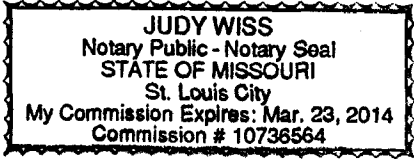
