**ASSIGNMENT OF TRADEMARKS**

THIS ASSIGNMENT OF TRADEMARKS (this "Assignment") is dated as of 10/3/2011, by and between JOHN E. DRAGOS, an individual, located at 1036 Lundvall Ave., Rockford, IL 61107 ("Assignor"), and MIKE JOHNSON, an individual, located at 16 Canidae Street, Burlington, NJ 08016 ("Assignee").

WHEREAS, Assignor is the owner of the entire right, title, and interest in and to the marks set forth on Attachment I ("Assigned Marks") hereto and Assignee is desirous in acquiring rights in said marks.

NOW, THEREFORE, for good and valuable consideration in the amount of US\$5,000, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns, transfers, and sets over unto Assignee, and Assignee hereby accepts, Assignor's entire right, title and interest in and to (i) the Assigned Marks, (ii) the goodwill of the business symbolized by the Assigned Marks, (iii) all right to apply for and maintain all applications, registrations, or renewals for the Assigned Marks, (iv) all common law rights associated with the Assigned Marks, (v) all causes of action and the right to sue, counterclaim, and recover for past, present, and future infringement of Assignor's rights in the Assigned Marks; (vi) copies of all promotional materials (including websites) in which the Assigned Marks have been used, to the extent such materials are available; and (vii) all licenses, consents, permissions and other agreements associated with or relating to the Assigned Marks.

Assignor will cooperate with Assignee to further the purposes of this Agreement, including by executing and delivering such assignments and consents as may be necessary for Assignee to exploit, record and register its rights as described above.

This Agreement shall extend to, inure to the benefit of, and be binding upon the parties and their respective partners, attorneys, agents, employees, representatives, affiliates, heirs, successors and assigns. Either party may assign its rights and obligations hereunder, in whole or in part, to any third party.

This Assignment sets forth the entire agreement between the Assignor and the Assignee with regard to the subject matter hereof. All prior agreements, and covenants, express or implied, oral or written, with respect to the subject matter hereof, are hereby superseded by this agreement.


This Assignment shall be governed by, and construed in accordance with, the laws of the State of Illinois applicable to contracts made and to be performed entirely in such state without regard to principles of conflicts or choice of laws or any other law that would make the laws of any other jurisdiction other than the State of Illinois applicable hereto.

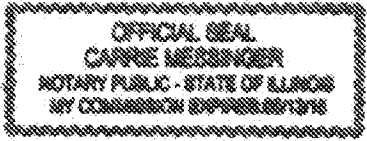
