RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, Quench USA, Inc., a Delaware corporation and successor-by-merger to Quench USA LLC ("**Grantor**"), has adopted, used and is the owner of the trademarks and trademark application listed on the attached **EXHIBIT A** (the "**Trademarks**");

WHEREAS, Grantor, entered into that certain Amended and Restated Intellectual Property Security Agreement dated as of August 29, 2008 (as amended, the "**IPSA**"), with **Gladstone Business Investment, LLC**, as successor-in-interest to Gladstone Investment Corporation ("**Gladstone**"); and

WHEREAS, pursuant to the **IPSA**, Grantor granted and pledged to Gladstone, among other things, a security interest in all of Grantor's right, title and interest in and to the Trademarks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Gladstone hereby releases any and all security interests, right, title and interest of Gladstone pursuant to the **IPSA** in: (i) the Trademarks, without recourse or representation or warranty, express or implied; (ii) and all applications to register and registrations of the same and like protections, and the entire goodwill of the business of Grantor connected with and symbolized by such Trademarks; (iii) all right, title and interest in and to any and all past, present, and future license agreements with respect to such Trademarks; and (iv) all past, present, and future accounts, accounts receivable and other rights to payment arising from, in connection with or relating to such Trademarks.

Gladstone shall, at Grantor's expense, take all further actions, and provide to Grantor, Grantor's successors, assigns or other legal representatives all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments) reasonably requested by Grantor that are necessary to effectuate this release or otherwise reasonably necessary to more fully and effectively effectuate the purposes of this release.

Grantor may file this release, in its sole discretion, with any government entity or authority that has oversight for intellectual property, such as trademarks, including the United States Patent Office.
