RELEASE OF TRADEMARK SECURITY INTEREST

WHEREAS, SeaChange International, Inc. is a Delaware corporation with a place of business at 50 Nagog Park, Acton, Massachusetts 01720 ("SeaChange"); and

WHEREAS, Silicon Valley Bank, a California corporation ("SVB") was the holder of a security agreement granting a security interest in certain trademarks dated November 10, 1998 and recorded in the U.S. Patent and Trademark Office ("USPTO") on December 7, 1998, at reel/frame number 1825/0034 (the "Security Agreement"); and

WHEREAS, SVB desires to confirm the previous termination of the Security Agreement and to execute and deliver to SeaChange all deeds, assignments and other instruments as may be reasonably necessary to confirm and record with the USPTO the release of the security interest relating to the trademarks set forth in the Security Agreement, which trademarks include those identified on Schedule A annexed hereto and made a part hereof (the "Trademarks").

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, SVB hereby confirms the relinquishment unto SeaChange of any security interest in and lien on the Trademarks and otherwise confirms the assignment, grant and conveyance to SeaChange of any and all rights SVB may have had in or to the Trademarks in order to revest in SeaChange full and unencumbered title to said Trademarks.
