RELEASE OF SECURITY INTEREST IN TRADEMARK

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK (the "Release") is made as of October 6th, 2011, by The Huntington National Bank, a national banking association, ("Lender") in favor of Terry's Tire Town, Inc., an Ohio corporation, ("Borrower").

WITNESSETH:

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of November 23, 2010 by and among Borrower and Lender (the "Intellectual Property Security Agreement"), Borrower granted a security interest in all of its trademarks in favor of Lender to secure certain debt owing from Borrower to Lender;

WHEREAS, Borrower has requested that Lender (i) terminate and release the lien and interest of Lender in the mark ONE PRICE DOES IT ALL, U.S. Registration No. 2,640,219, (the "Trademark"), and (ii) execute and deliver evidence of such termination and release for filing in the United States Patent and Trademark Office and other appropriate offices; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby releases and terminates its security interest in the Trademark, and reassigns to Borrower all right, title and interest of Lender in and to the Trademark.


