RELEASE AND TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This RELEASE AND TERMINATION OF SECURITY INTEREST IN TRADEMARKS ("Release and Termination") is executed as of October 10, 2011, by Bank of Montreal, as Agent (the "Agent"), a Canadian chartered bank with its mailing address at 111 West Monroe Street, Chicago, Illinois 60603, with reference hereby made to those certain Trademark Collateral Agreements dated as of October 31, 2007 and May 22, 2008 (collectively, the "Trademark Collateral Agreements"), by Tranzact Information Services LLC (formerly known as Tranzsubco III Corp., formerly known as Marketer.net Holdings, LLC) a Delaware limited liability company ("Tranzact") with its principal place of business and mailing address at 301 Yamato Road, Suite 4150, Boca Raton, Florida 33431 in favor of the Agent.

WHEREAS, Tranzact has requested that the Agent release the liens and security interests granted to it in the right, title and interest in and to the trademarks of Tranzact, together with the goodwill of the business symbolized thereby, set forth on Schedule I attached hereto (the "Trademarks"), pursuant to the Trademark Collateral Agreement.

For good and valuable consideration, the receipt of which is hereby acknowledged:

The Agent does hereby certify that the security interests it holds in the right, title and interest to the Trademarks, pursuant to the Trademark Collateral Agreements which were recorded with the United States Patent and Trademark Office on November 5, 2007 at Reel/Frame: 3654/0236 and on October 8, 2008 at Reel/Frame: 3867/0041, respectively, are released and terminated and all interests in such property previously assigned to the Agent under the Trademark Collateral Agreements are hereby reassigned to Tranzact, without recourse or representation or warranty, express or implied, of any kind.

This Release and Termination shall be governed by the laws of the Commonwealth of Massachusetts and shall relate solely to the Trademark Collateral Agreements.

The Agent authorizes and requests that the Commissioner for Trademarks and any other applicable United States government officer record this Release and Termination.
