TRADEMARK ASSIGNMENT

THIS ASSIGNMENT is made the 22nd day of September, Two Thousand and Eleven,

BETWEEN RockTenn CP, LLC, a limited liability company organized under the laws of the State of Delaware, USA, having a principal business address at 504 Thrasher Street, Norcross, GA, USA, (hereinafter called "the Assignor") of the one part,

AND Smurfit Kappa Investments Limited, a company incorporated under the laws of Ireland with a registered address at Beech Hill, Clonskeagh, Dublin 4, Ireland (hereinafter called "the Assignee") of the other part,

WHEREAS the Assignor is the registered Proprietor of United States Trade Mark Registration No 1,152,398 (hereinafter called "the said Trade Mark") the particulars of which are set out in the Schedule hereto,

AND WHEREAS, the Assignor has acquired all right, title, interest and goodwill in the said Trade Mark as successor, by merger, to Smurfit-Stone Container Corporation, a company incorporated in Delaware with an address at Six Cityplace Drive, Creve Coeur, Missouri 63141,

AND WHEREAS the Assignor has agreed to assign the said Trade Mark together with the goodwill of the business symbolised therewith to the Assignee for the consideration hereinafter appearing,

NOW THIS DEED WITNESSETH that in consideration of the sum of €10 now paid by the Assignee to the Assignor and other good and valuable consideration (the receipt whereof the parties hereby acknowledge), the parties agree as follows:

1. The Assignor as beneficial owner hereby assigns unto the Assignee **ALL THAT** the said Trade Mark together with the goodwill of the business symbolised therewith **TO HOLD** the same unto the Assignee absolutely.

2. The Assignee agrees that (a) this assignment is provided "as is" without warranty; and (b) the Assignor makes no warranty, and disclaims all warranties, express and implied, related to the nature, use, title, scope, incontestability, validity, enforceability, or transferability of the Trade Mark, any related registrations, and business goodwill associated therewith. The Assignee agrees that no such warranties have been or are made by the Assignor, or by its parents, subsidiaries or affiliates, or their respective officers, directors, employees, agents or representatives.

3. The Assignee agrees that the Assignor is under no obligation to (a) assist with registration, defence or enforcement of the Trade Mark, or (b) provide testimony, specimens, and other evidence of use regarding the Trade Mark, and the Assignee agrees not to involve the Assignor in any action or proceeding regarding such registration, defence or enforcement.


