2. I make this declaration of my own personal knowledge.
3. Rosehoff Limited is the true owner of U.S. registration no. 3,819,984 on the Principal Register of the United States Patent and Trademark Office, for the trademark CATACLEAN ("Reg. No. '984")
4. Rosehoff Limited obtained ownership of CATACLEAN and Reg. No. '984 by assignment from me, Hugh F. Collins, dated May 17, 2011, and recorded with the Assignment Services Branch of the U.S. Patent and Trademark Office on June 8, 2011, at Reel 4556, Frame 0721.


