**RELEASE OF SECURITY INTEREST**  
**(TRADEMARK AND PATENT)**

WHEREAS, MAGNUM PRODUCTS, LLC, a Wisconsin limited liability company (the "Grantor"), and PNC BANK, NATIONAL ASSOCIATION, as agent (the "Lender"), are parties to one or more loan and security agreements, including that certain Trademark and Patent Security Agreement, dated July 16, 2010 (the "Security Agreement") entered into in connection with that certain Revolving Credit and Security Agreement, dated July 16, 2010, by and among the Grantor, the Lender, TOM JOSEPH, INC., a Florida corporation, MAGNUM PRODUCTS INTERNATIONAL, INC., a Delaware corporation, MAGNUM PRODUCTS CANADA, INC., a Wisconsin corporation and MAGNUM PRODUCTS SERVICES, LLC, a Wisconsin limited liability company, which grant to the Lender a security interest in the Grantor's intellectual property assets, including, but not limited to, the trademarks, trademark applications, patents and patent applications listed in the attached **Schedule 1**;

WHEREAS, the Grantor has fully and timely satisfied all of the Grantor's obligations to the Lender with respect to said Security Agreement.

NOW, THEREFORE, the Lender states as follows:

The Lender hereby certifies that the Grantor has satisfied all obligations to the Lender with respect to said loan and security agreements, and hereby releases and discharges the Grantor from all such obligations and terminates the security interest in all of the intellectual property assets referred to in the above-noted loan and security agreement and to the trademarks and trademark applications and patents and patent applications listed in the attached **Schedule 1**. The Lender hereby agrees that the Security Agreement and the Power of Attorney executed by Grantor in favor of Lender in connection therewith are terminated and of no further force and effect.



