TRADEMARK ASSIGNMENT AGREEMENT

Assignee hereby accepts such assignment and transfer.

Assignor further agrees that Assignor will, at the request but at the expense of Assignee, do all commercially reasonable lawful and just acts, including the execution and acknowledgment of instruments that are or become necessary for obtaining, sustaining, or reissuing the Trademarks, and for maintaining and perfecting Assignee's right to the Trademarks.
