TRADEMARK ASSIGNMENT


NOW, THEREFORE, for good and valuable consideration, paid by Assignee to Assignor, receipt of which is hereby acknowledged, Seller hereby sells, grants, assigns, transfers, conveys and delivers to Assignee all of his right, title and interest in, to and under the Mark, whether statutory or at common law, together with the goodwill of the business in connection with which the Mark are used in the United States, Canada and elsewhere throughout the World and all registrations and applications to register the Mark, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignor if this Assignment had not been made, together with all claims for damages and other relief by reason of past, present or future infringement or other unauthorized use of the Mark, with the right to sue for damages, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.

Assignor hereby authorizes and requests the Commissioner of Trademarks of the United States to record Assignee as the owner of the Mark. Upon the request of Assignee, and at no additional consideration, Assignor agrees to execute further papers and to do such other acts as may be necessary and proper to vest full title in and to the Mark in

the Assignee or which may be necessary to obtain, renew, issue or enforce the Mark. This Assignment is governed exclusively by New York Law.
