TRADEMARK ASSIGNMENT

The Assignor hereby covenants that no assignment, sale, agreement, or encumbrance has been or will be made or entered into with respect to the Trademark Rights that would conflict with this Assignment.

Each party agrees to promptly execute and deliver to the other party or its legal representatives all papers, instruments or affidavits required to carry out, record and/or effectuate the purposes of this Assignment.
