1. I am properly authorized to execute this declaration on behalf of Image Entertainment, Inc. ("Image Entertainment").
2. I am currently the Vice President, Corporate Affairs ("VP CA") of Image Entertainment, and have held that position since at least August 16, 2010.
3. In my position as VP CA, I am familiar with Image Entertainment's trademarks, including the mark IMAGE (the "Mark").
4. In my capacity as VP CA, I am familiar the use of Image Entertainment's trademarks as security for certain financing arrangements.
5. Based on my review of corporate records in my capacity as VP CA, I am aware that in 1991, pursuant to a security agreement (the "1991 Security Agreement"), Image Entertainment granted to Sun Life Insurance Company of America ("Sun Life") a security interest in certain of Image Entertainment's intellectual property (the "Security Interest"),


including the Mark, as security for a debt owed by Image Entertainment to Sun Life (the "Debt").

6. Based on my review of corporate records in my capacity as VP CA, I am aware that the Debt has been repaid in full, and therefore, that the Security Interest is released pursuant to the terms of the 1991 Security Agreement.

7. All statements made of my own knowledge are true and statements made on information and belief are believed to be true.
