AND WHEREAS the Assignor is willing to sell, assign, transfer and convey such rights unto Assignee for the said "DYNAMAXX";



THE Assignor hereby further agrees, undertakes and covenants that they will sign or execute such further documents, assurances, applications, instruments or any other writing that may be requested by the Assignee or their legal representatives for the purpose of obtaining or


issuing any registration for the trade-mark therein in order that all of their right, title and interest in the same may be vested in the Assignee, its successor and assigns.




