TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of October 4, 2011 by ANTARES CAPITAL CORPORATION, as Agent for the Lenders (the “**Bank**”) in favor of LAKE LAND FINANCE, LLC (“**Grantor**”). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Credit Agreement and/or Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, Grantor, Bank and the other parties thereto entered into that Certain Credit Agreement dated as of December 15, 2005 (the “**Credit Agreement**”).

WHEREAS, pursuant to that certain Borrowers Security Agreement dated as of December 15, 2005 among Bank, Grantor, and the other parties thereto (the “Security Agreement”), Grantor granted to Bank a security interest in all of its right, title and interest in, to and under certain intellectual property and, in connection therewith, entered into that certain Trademark Security Agreement dated as of January 18, 2011 (the “**Assignment**”) for the purpose of recording such security interest with respect to the Trademark Collateral (as such term is defined in the Assignment), which included the trademark registrations, trademark applications and trademark licenses set forth on Schedule 1 hereto, with the United States Patent and Trademark Office; and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on January 18, 2011, at Reel 4455, Frame 0268; and

WHEREAS, Grantor has requested that Bank release its security interest in all of Grantor’s right, title and interest in, to and under the Trademark Collateral and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Bank hereby releases its security interest in all of Grantor’s right, title and interest in, to and under the Trademark Collateral.

2. Bank hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Bank, all of Bank's right, title and interest in, to and under the Trademark Collateral

3. Bank shall, at Grantor’s expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all

documents or other instruments, reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Trademark Release and Reassignment.
