## TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of October 4, 2011 by CHARLESBANK CAPITAL PARTNERS, LLC, a Massachusetts limited liability company (“**Grantee**”), as successor trustee and collateral agent under the Indenture (as defined below) in favor of LAKELAND FINANCE, LLC (the “**Grantor**”).

### WITNESSETH:

WHEREAS, Grantor, WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association, as former collateral agent under the Indenture (the “**Former Collateral Agent**”), and the Guarantors (as defined therein) entered into that certain Indenture dated as of December 15, 2005 (as amended, the “**Indenture**”), pursuant to which the Former Collateral Agent acted as trustee for the holders of certain of Grantor’s 16% Senior Secured Notes due 2014 (the “**Holders**”);

WHEREAS, pursuant to that certain Security Agreement, dated as of December 15, 2005, among Grantor, the other parties thereto and the Former Collateral Agent, as collateral agent (the “**Security Agreement**”), Grantor granted to Grantee a security interest in all of its right, title and interest in, to and under certain intellectual property and, in connection therewith, entered into that certain Trademark Security Agreement, dated as of December 15, 2005 (the “**Trademark Security Agreement**”), for the purpose of recording such security interest with respect to the Trademark Collateral (as such term is defined in the Trademark Security Agreement), which included the trademark registrations, trademark applications and trademark licenses set forth on Schedule 1 hereto, with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on December 16, 2005, at Reel 3211, Frame 0715;

WHEREAS, on April 28, 2010, the Former Collateral Agent resigned as trustee under the Indenture and the Holders appointed Grantee as successor trustee under the Indenture;

WHEREAS, Grantor, the Former Collateral Agent and Grantee entered into that certain Assignment and Assumption Agreement, dated as of April 28, 2010 (the “**Assignment Agreement**”), pursuant to which the Former Collateral Agent transferred and assigned to Grantee all of the Former Collateral Agent’s right, title and interest in, to and under the Trademark Security Agreement from and after such date, and in connection therewith, entered into that certain Notice of Assignment of Security Interest in Trademarks (the “**Notice of Assignment**”);

WHEREAS, the Notice of Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on February 8, 2011, at Reel 4471, Frame 0001; and

WHEREAS, Grantor has requested that Grantee release its security interest in all of Grantor's right, title and interest in, to and under the Trademark Collateral and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby releases its security interest in the Grantor's right, title and interest in, to and under the Trademark Collateral.


2. Grantee hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Grantee, all of Grantee's right, title and interest in, to and under the Trademark Collateral.

3. Grantee shall, at Grantor's expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Trademark Release and Reassignment.
