## AMENDMENT OF ARTICLES OF INCORPORATION

Pursuant to the provisions of The General and Business Corporation Law of Missouri, the undersigned Corporation certifies the following:

1. The present name of the Corporation is: **Kranson Industries, Inc.**

The name under which it was originally organized was: **Northwestern Bottle Company.**

2. An amendment to the Corporation's Articles of Incorporation was adopted by the sole shareholder on **November 4, 2010.**


