WHEREAS, Assignor desires to assign to Assignee and Assignee desires to accept such assignment of the entire right, title and interest in and to the Trademarks.

WHEREAS, Assignor wishes to assign all his right, title and interest in the Trademarks to Assignee as a gift to Assignee;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. The above recitals are made a part of and incorporated into this Assignment.
2. Assignor hereby transfers, grants, conveys, assigns, and relinquishes exclusively to Assignee, and its successors, assigns and legal representatives, all of Assignor's right, title, and interest in and to the Trademarks together with the goodwill of any business connected with the use of and symbolized by such marks including the right to sue for, settle, or release any past, present, or future infringement thereof or unfair competition involving the same. Assignor further transfers and assigns the right to file for and obtain registered trademarks or service marks of the Trademarks anywhere in the world with the right to base priority on Assignor's first date of use. Assignor covenants not to contest or challenge the validity of the Trademarks, any applicable applications or registrations thereof or the ownership of the Trademarks by Assignee. Assignor shall provide to Assignee, its successors, assigns or other representatives, reasonable and prompt cooperation and assistance as may be reasonably required in connection with (i) effectuating the purposes of this Assignment (including without limitation by executing and delivering affidavits, declarations, oaths, exhibits, assignments, powers of attorney and other documentation to perfect Assignee's right, title and interest in and to the Trademarks), and (ii) preparing any applications relating to the Trademarks. Nothing in this Section 3 shall require Assignor to pay any amounts or make any expenditures with respect to its obligations under this Section 2.
3. In addition to the assignment by Assignor to Assignee of all Trademarks scheduled herein, Assignor also hereby transfers, grants, conveys, assigns, and relinquishes exclusively to Assignee, and its successors, assigns and legal representatives, all of Assignor's right, title, and interest including any ownership in and to the "corporate names", such names being "TM ONE HOLDING COMPANY" and "TM HOLDING ONE COMPANY," (which includes any derivative or abbreviation of either corporate name, i.e. TM ONE HOLDING INC.; TM1; or any other derivative thereof) together with the goodwill of any business connected with the use of and symbolized by such incorporated names. The assignment of the corporate names to Assignee shall also include an irrevocable assignment and conveyance of any and all holdings, assets, stock, any pending trademark or service mark registrations or filings inadvertently omitted or not scheduled or included in the recital herein, including any and all agreements entered into by Assignor with any third party or parties, including but not limited to, any and all Contracts or Agreements and Amendments to such Contracts or Agreements between TM ONE HOLDING COMPANY and or TM HOLDING ONE COMPANY and Tom Palecki, individually and or d/b/a AZ GUITARS, AZG, PEAR, PEAR GUITARS, PEAR CUSTOM GUITARS or Tom Palecki conducting or doing business under other name, entity, moniker and or corporate name. Assignor agrees that this Agreement entitled "Assignment of Trademarks" shall forever bar and preclude Assignor from contesting, challenging or making any claim at any time, against any of the properties scheduled or not scheduled under this Assignment and/or against the Assignee, including but not limited to Assignee's heirs and executors.

4. This Assignment may be executed in any number of counterparts, each of which shall be deemed an original but all of which together shall constitute one and the same instrument.
