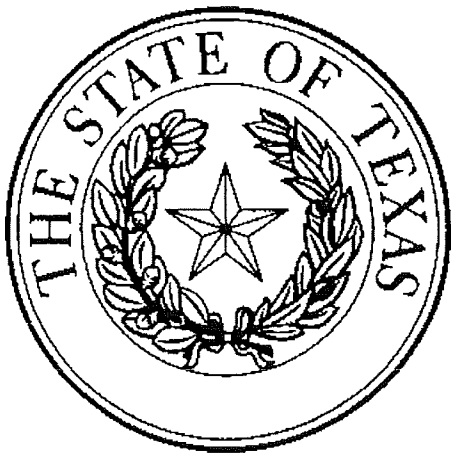

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned directors adopt the following Article of Amendment to the Articles of Incorporation of Luther's Bar-B-Q, Inc.

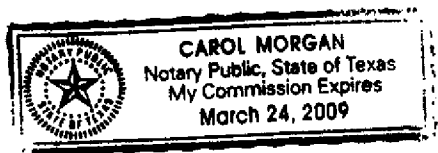
