**RELEASE OF SECURITY INTEREST**





This Release of Security Interest (hereinafter referred to as this "Release") is effective as of the 5th day of August, 2011, by and between FCC, LLC d/b/a First Capital having a place of business at 565 Fifth Avenue, 19<sup>th</sup> Floor, New York, New York 10017 (hereinafter referred to as "FCC") and I. Spiewak & Sons, Inc., a New York corporation having a place of business at 463 Seventh Avenue, 11<sup>th</sup> Floor, New York, New York 10018 (hereinafter referred to as "Spiewak").

WHEREAS, Spiewak and G&G s.r.l., a corporation organized under the laws of Italy, have or will enter into a Trademark Assignment and Asset Purchase Agreement on or about the date of this Release (the "Asset Purchase Agreement"); and

WHEREAS, FCC acquired a security interest in certain property owned by Spiewak; and

WHEREAS, in conjunction with the Asset Purchase Agreement, Spiewak has requested and FCC has agreed to release FCC's security interest with respect to certain assets associated with Spiewak's fashion outerwear market including certain trademarks owned by Spiewak related thereto.

NOW, THEREFORE, for good and adequate consideration, the receipt and sufficiency of which is hereby acknowledged:

Spiewak & Sons" and any other corporate name containing the word "SPIEWAK" in combination with word "Uniform" and/or "Industrial" (collectively, the "Excluded Marks"), FCC hereby releases all right, title and interest, including all security interests and liens, that it may have in and to (i) the trademarks identified in Exhibit A, and all registrations and applications for registration of same, together with the goodwill of the business associated therewith and symbolized thereby, (ii) all rights therein at common law, (iii) all rights to sue for infringement of any such trademark, whether arising prior to or subsequent to the date of this Release, and any and all renewals and extensions thereof that may hereafter be secured under the laws now or hereafter in effect in the United States and in any other jurisdiction (collectively, the "Purchased Marks").
  2. Except those assets set forth on Exhibit C (collectively, the "Excluded Assets") and those assets not sold by Spiewak pursuant to the Asset Purchase Agreement, FCC hereby releases all right, title and interest, including all security interests and liens, that it may have in and to those assets owned or used by Spiewak in connection with the Fashion Division set forth on Exhibit B (collectively, the "Purchased Assets").
  3. Capitalized terms used in this Release and its Exhibits but not defined in this Release have the meanings given to such terms in the Asset Purchase Agreement.
