**RELEASE OF TRADEMARK
SECURITY AGREEMENT**

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT, dated as of October 17, 2011, is made by ORIX CORPORATE CAPITAL, INC. (f/k/a ORIX FINANCE CORP.), a Delaware corporation, for itself, as a lender, and as agent for the Lenders (as defined below) (in such capacities, "Agent").

WHEREAS, pursuant to that certain Credit Agreement, dated as of September 15, 2006, by and among GAMMILL, INC., a Delaware corporation ("Grantor"), Agent and the several financial institutions from time to time party thereto (collectively, the "Lenders") (including all annexes, exhibits and schedules thereto, as from time to time amended, restated, supplemented, or otherwise modified, the "Credit Agreement"), Grantor and Agent are parties to that certain Trademark Security Agreement, dated as of September 15, 2006 (the "Agreement"), which was recorded with the United States Patent and Trademark Office on September 18, 2006 in its records at Reel 3392, Frame 0001;

WHEREAS, pursuant to the Agreement, Grantor granted to Agent, on behalf of itself and the Lenders, a continuing first priority security interest in all of Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the "Trademark Collateral"): all of its Trademarks and Trademark Licenses (as defined in the Agreement) against assignment to which it is a party including those referred to on Schedule I hereto; all renewals or extensions of the foregoing; all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark License; and all products and proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or Trademark licensed under any Trademark License or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License.

WHEREAS, Agent desires to release its rights and security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby fully and finally releases and terminates (i) its security interest and other rights in, to and under the Trademark Collateral (ii) any and all other rights it may have under the Agreement.
