3. MSA hereby covenants that Safety Works, LLC will, upon its request, be provided promptly with all pertinent facts and documents relating to the Trademarks and the registration thereof, as may be known and accessible to MSA, and that MSA will testify as to the same in any opposition, cancellation, litigation or proceeding relating thereto and will promptly execute and deliver to Safety Works, LLC or its legal representatives any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue or enforce the Trademarks and the registration thereof, which may be necessary or desirable to carry out the purposes or enjoyment thereof. MSA's obligations under this paragraph are limited to those things that MSA reasonably has the power to perform or cause to be performed.

4. MSA hereby covenants that it has not done and will not do any act, matter or thing whereby the Trademarks or any registrations thereof, may be invalidated.

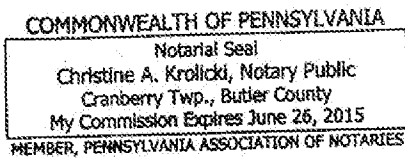
