## RELEASE OF TRADEMARK SECURITY AGREEMENT

This Release of Trademark Security Agreement ("Release") is dated as of July 8, 2011 by and between MB Financial Bank, N.A., a national banking association (the "Releasing Party"), and Primus Sterilizer Company, LLC a Delaware limited liability company (the "Borrower").
