TRADEMARK ASSIGNMENT

Without limiting the generality of the foregoing, Assignor further sells, assigns and transfers to Assignee all right, title and interest to sue and recover for past infringements by any third parties of the Marks.

2. APPLICABLE LAW

This Agreement shall be governed and construed in accordance with the laws of the State of Michigan, applicable to contracts to be made and performed entirely therein without giving effect to the principles of conflicts of law thereof or any other jurisdiction.

3. MODIFICATIONS

This Agreement may be changed only by written amendment signed by both parties.


