TRADEMARK ASSIGNMENT

WHEREAS, Wannaplay Products, LLC ("Assignor"), a limited liability company of the State of Michigan, located at 4820 Leland Road, Laingsburg, Michigan 48848, owns trademark rights in the WANNAPLAY trademark (the "Mark"). Such rights include U.S. Trademark Registration No. 2719941 as well as common-law rights and goodwill in the Mark resulting from use of the Mark by Assignor and/or Assignor's predecessors in interest, related companies, and/or licensees (collectively, with the Mark, the "Trademark Property"). Assignor first used the Mark in U.S. commerce on or in connection with "T-shirts, sweatshirts, golf shirts, headwear, caps, sweaters, jackets, scarves, shorts, and jeans" at least as early as November 1, 2002, and Assignor continued to use that mark until the date signed below, and never abandoned the mark.

WHEREAS, National Association of Music Merchants, Inc. ("Assignee"), a corporation of the State of New York, located at 5790 Armada Drive, Carlsbad, California 92008, desires to acquire all of Assignor's right, title, and interest in the Trademark Property.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns to Assignee, all of Assignor's right, title, and interest in and to the Trademark Property; and the right to sue and collect damages against third parties for all instances of past and future trademark infringement, unfair competition, trademark dilution, and other violations of the Lanham Act and analogous state laws, with respect to the Trademark Property. Assignor shall have no remaining rights whatsoever in the Trademark Property.
