**RELEASE OF INTELLECTUAL  
PROPERTY SECURITY AGREEMENT**

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of October 18, 2011, is made by GLADSTONE CAPITAL CORPORATION, a Maryland corporation, as Agent for the Lenders (as defined in the Credit Agreement) ("Agent").

WHEREAS, pursuant to that certain Credit Agreement, dated as of December 26, 2003, by and among GAMMILL, INC. (f/k/a GQM ACQUISITION CORP.), a Delaware corporation (the "Borrower"), Agent and the Lenders (the "Credit Agreement"), Borrower and Agent are parties to that certain Intellectual Property Security Agreement, dated as of December 26, 2003 (the "Agreement"), which was recorded with the United States Patent and Trademark Office on December 29, 2003 in its records at Reel 2770, Frame 0366;

WHEREAS, pursuant to the terms of the Security Agreement (as defined in the Credit Agreement), Borrower granted and pledged to Agent a security interest in all of Borrower's right, title and interest in, to and under its Intellectual Property (as defined in the Credit Agreement), including without limitation those copyrights, patents and trademarks listed on Schedules A, B and C hereto, and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions continuations, renewals, extensions and continuations-in-part thereof.

WHEREAS, Agent desires to release its rights and security interest in the Intellectual Property.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby fully and finally releases and terminates (i) its security interest and other rights in, to and under the Intellectual Property (ii) any and all other rights it may have under the Agreement.
