RELEASE OF SECURITY INTEREST IN TRADEMARK

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK (this "Release") is made as of October 21, 2011 ("Effective Date") by The Prudential Insurance Company of America ("Grantee"), in favor of Oasis Outsourcing Holdings, Inc. ("Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Assignment of Security Interest in Trademarks, dated as of February 16, 2006 (the "2006 Assignment"), Grantor assigned, transferred and conveyed to Grantee, and granted to Grantee, a security interest in all of Grantor's right, title and interest in and to the Collateral;

WHEREAS, the 2006 Assignment was recorded with the United States Patent and Trademark Office on February 22, 2006 at Reel 003251, Frame 0482; and

WHEREAS, Grantee has consented to the release of the Lien on the Collateral listed on Schedule 1 hereto (the "Intellectual Property Collateral");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

1. Grantee's Lien in the Intellectual Property Collateral granted pursuant to the 2006 Assignment is hereby terminated and released.



To the extent Grantee retains any such interest, Grantee hereby assigns, transfers and conveys to Grantors, all of Grantee's right, title and interest, now owned or hereinafter acquired, that it may have whether by assignment or otherwise, in and to any mortgage and continuing security interest and collateral assignment in the Intellectual Property Collateral. Such assignment, transfer and conveyance by Grantee is made without any representation or warranty (express or implied) by Grantee.

3. Grantee hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release, all at the expense of Grantors.
