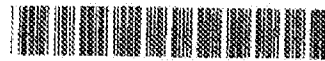

## ASSIGNMENT

ASSIGNMENT, dated as of March 30, 2000, by Physician Computer Network, Inc., VERSYSS Incorporated, PCN HP Venture Corp., Integrated Health Systems, Inc. and Wismer\*Martin, Inc. (hereinafter referred to, collectively, as the "Assignors"), in favor of Medical Manager Corporation, a Delaware corporation (the "Assignee").

### Background

The Assignors, Assignee and Medical Manager Corporation are parties to a certain Asset Purchase Agreement, dated as of December 7, 1999 (as amended by Amendment No. 1 thereto, the "Agreement"), pursuant to which the Assignors have agreed to assign to Assignee, all of Assignors' rights, title and interests in and to the Intellectual Property.

## **Section 5. Definitions**



AIX - AIX is one of the Operating Systems that PCN Health Network, MENDS ICF and MDX operates on. It is licensed from IBM as is and PCN pays a royalty to IBM for each system (on a per user basis) that is sold.

SCO - SCO Unix is one of the Operating Systems that PCN Health Network, MENDS ICF and MDX operates on. It is licensed from Santa Cruz Operation Inc. as is and PCN pays a royalty to SCO for each system (on a per user basis) that is sold.
