**RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARK**

This RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARK (this “Release”), dated and effective as of October 25, 2011, is made by CREDIT SUISSE AG, Cayman Islands Branch (formerly Credit Suisse First Boston, “CREDIT SUISSE”), to and in favor of QSI SERVICES, INC. and its successors and assigns, including without limitation, QUALAWASH HOLDINGS, LLC (collectively, “QUALAWASH”).

WHEREAS, pursuant to that certain Grant of Security Interest in United States Trademarks, dated November 13, 2003 (the “GRANT OF SECURITY INTEREST”), CREDIT SUISSE was previously granted a security interest in the mark QUALAWASH, having the Registration No. 1,373,003 (the “TRADEMARK”), in connection with certain financing arrangements between CREDIT SUISSE and QUALAWASH, which security interest was recorded in the United States Patent and Trademark Office on January 13, 2004 at Reel 2894, Frame 0721; and


WHEREAS, CREDIT SUISSE intends to release its security interest in the TRADEMARK as set forth herein;


NOW THEREFORE, CREDIT SUISSE hereby **RELEASES** all of its security interest in the TRADEMARK, as granted pursuant to the Grant of Security Interest, and CREDIT SUISSE hereby assigns all such right, title and interest (if any) that CREDIT SUISSE may have in the TRADEMARK under the Grant of Security Interest to QUALAWASH. All goodwill associated therewith inures to the benefit of QUALAWASH.

CREDIT SUISSE authorizes QUALAWASH to record this Release.
