As of the Effective Date, Assignor hereby sells, assigns and transfers to Assignee, its successors and assigns, all right, title and interest in, to and under the Trademark including any and all goodwill associated therewith, all registrations therefor, all common law rights therein, any and all trademark and/or service mark rights related thereto and all other rights associated with the portion of the ongoing and existing business to which these marks pertain; and in and to any all causes of action (either in law or in equity), as well as the right to enforce any rights and file any causes of action, including the right to recover damages, for any past, present or future infringement, misappropriation and/or dilution of the Trademark.

2. Assignor hereby agrees to, at the expense of Assignee, execute, acknowledge and deliver any and all documents and to take such other and further actions as Assignee, in its reasonable discretion deems desirable or necessary to make a record with any and all government agencies, authorities, courts, tribunals, or third parties, of the fact that Assignee owns all right, title and interest in and to the Trademark, and any and all goodwill associated therewith, as well as all other rights associated with the portion of the business to which the Trademark pertains and that Assignor no longer has any rights, title or interest, of any kind or nature, in or to the Trademark.

3. Assignor hereby authorizes and requests the U.S. Patent and Trademark office to record Assignee as the owner of the Trademark.

4. In the event of any conflict or inconsistency between the terms of this Trademark Assignment and the terms of the Settlement Agreement, the Terms of this Trademark Assignment shall prevail.

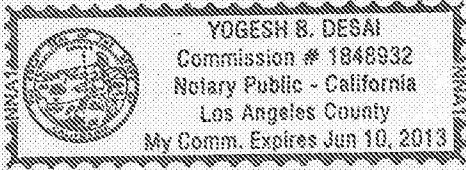
