INTELLECTUAL PROPERTY SECURITY AGREEMENT

This INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Agreement"), dated as of October 26, 2011, is entered into by and between Pizza Inn, Inc., a Missouri corporation (including any permitted successors and assigns, the "Debtor") and Amegy Bank National Association (the "Lender") on behalf of itself and its Affiliates (the "Secured Party").

WHEREAS, Pizza Inn Holdings, Inc., a Missouri corporation (the "Borrower"), has entered into that certain Amended and Restated Loan Agreement dated as of the date hereof between the Borrower and the Lender (as it has been or may be amended, supplemented, restated or modified from time to time, the "Loan Agreement").

WHEREAS, as a condition precedent to the making of the credit extensions by the Lender under the Loan Agreement, the Debtor has executed and delivered in favor of the Secured Party that certain Amended and Restated Security Agreement dated as of the date hereof (as it has been or may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"). Terms defined in the Security Agreement (including terms defined by reference to the Loan Agreement) and not otherwise defined herein are used herein as defined in the Security Agreement.

WHEREAS, under the terms of the Security Agreement, the Debtor has granted to the Secured Party, a security interest in, among other property, all Intellectual Property of the Debtor, and has agreed as a condition thereof to execute this Agreement for recording with the United States Patent and Trademark Office, the United States Copyright Office and other Governmental Authorities.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Debtor agrees as follows:

1. **Grant of Security.** Debtor hereby grants to the Secured Party, a security interest in all of Debtor's right, title and interest in and to the following (collectively, the "Collateral"):

1.1. the patents and patent applications set forth in Schedule A hereto (the "Patents");

1.2. the trademark and service mark registrations and applications set forth in Schedule B hereto, together with the goodwill symbolized thereby (the "Trademarks");

1.3. all copyrights, whether registered or unregistered, now owned or hereafter acquired by Debtor (the "Copyrights");

1.4. all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of Debtor accruing thereunder or pertaining thereto;

1.5. any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of

the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and

1.6. any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any and all of the Collateral of or arising from any of the foregoing.

2. **Security for Obligations.** The grant of a security interest in, the Collateral by the Debtor under this Agreement secures the prompt and complete payment and performance when due of all Secured Obligations of Debtor, whether direct or indirect, now existing or hereafter arising, absolute or contingent, and whether for principal, reimbursement obligations, interest, premiums, penalties, fees, guarantee obligations, indemnifications, contract causes of action, costs, expenses or otherwise.

3. **Recordation.** Debtor authorizes and requests that the Register of Copyrights, the Commissioner for Patents and the Commissioner for Trademarks and any other applicable Governmental Authority record this Agreement.

4. **Execution in Counterparts.** This Agreement may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

5. **Grants, Rights and Remedies.** This Agreement has been entered into in conjunction with the provisions of the Security Agreement. Debtor does hereby acknowledge and confirm that the grant of the security interest hereunder to, and the rights and remedies of, the Secured Party with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated herein by reference as if fully set forth herein.

6. **Governing Law.** This Agreement shall be governed by, and construed in accordance with, the laws of the State of Texas.

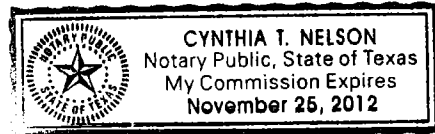

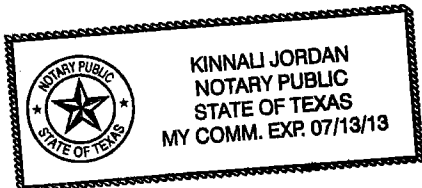


