RESOLVED, that Article I of the Articles of Incorporation is hereby amended to read, in its entirety, as follows:

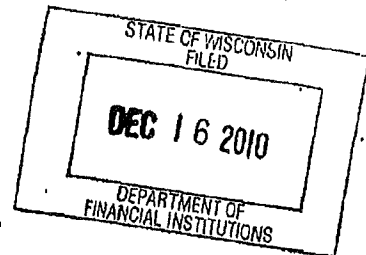
"Article 1. The name of the Corporation is Gen-Probe GTI Diagnostics, Inc."
